1. NATURE OF BUSINESS

The Centre is a not for profit youth services society incorporated under the Society Act of British Columbia on December 5, 1994. The centre operates activities that are exempt from Canadian Income tax under subsection 149(L) of the Canadian Income Tax Act. The Centre is a registered charity with the Canada Revenue Agency.

2. BASIS OF ACCOUNTING

The accompanying compiled financial information has been prepared on the historical cost basis, reflecting cash transactions with the addition of:

- (i) accounts receivable less an allowance for doubtful accounts
- (ii) inventory accounted for at the lower of cost and net realizable value
- (iii) accounts payable and accrued liabilities
- (iv) prepaid expenses setup for expenditures that carry over the year-end
- (v) capital expenditures are expensed

I am happy to report that the Summit Youth Hub Centre continues this year to be in a sound financial position and the year has ended on a positive note. The accounts have been reviewed and a Notice to Reader was prepared by the accounting firm Ascend CPAs. There has been no audit or review engagement of the financials statements for the year ended June 30, 2023. Thus there is no audit opinion expressed or review conclusion provided by the accounting firm. Please find attached the Year End Financial Statements.

Revenue:

Total revenues were up 41% from the previous fiscal. This is due to the addition of the Telus Youth Mental Health grant of 20K and 65K from the United Way. We are grateful to all the organizations, individuals and foundations who support the Summit Youth Hub. We would not be able to operate without their generosity.

Expenses:

Staffing continues to be our largest expense. The 60% increase of wages is due to addition of outreach worker and adjusting wages closer to industry standards for attracting and retaining of staff. Program costs decreased this fiscal with the end of the food insecurity project and creativity project. There were no capital purchases this fiscal year. Other expenses remained constant to the previous year.

Chairperson's Report

Windermere Valley Youth Centre Society

Since we were last together in November of 2022, the Windermere Valley Youth Centre Society has experienced tremendous change.

If you look around the Youth Hub you'll notice a change in flooring, a change in paint colors, a change in our virtual reality system, new gaming computers, new furniture and a new set up.

When you compare year over year financials you'll notice a significant change in revenue. There were periods of time where gaps in funding required the board to make choices to ensure fiscal responsibility. I am pleased share, and as you would have noticed in our revenues, that we were awarded the United Way Grant making possible a new outreach worker position changing our available for youth and a sizeable grant from Telus increasing access to supports by phone and text. We are grateful for the continued support from W. Brett Wilson through the Columbia Valley Community Foundation which affords our summer 'on the road' program. I was honored to represent the Society at the CVCF Garden Party in June to share how their contribution has supported youth in the valley.

On the theme of change, The Vancouver Foundation changed their focus to provide equal access to communities throughout the province and WVYCS was awarded the Community Services Recovery Fund beginning fiscal July 1, 2023, over a three-year period. This funding has changed our financial position post year end and supported the Board in being able to offer competitive salaries as well as shared cost benefits.

In post pandemic world, WVYCS was able to change how we interact with our communities. Led by our staff we have taken a number of opportunities to increase our visibility within the community and join events and festivals that bring us to our youth.

WVYCS has renewed our partnership with Edgewater Recreation Society which allows us to continue to meet youth where they live. And we continue to look for partnership opportunities with Columbia Valley Youth Network providing engagement opportunities in Canal Flats.

If you look around the table at our staff you'll notice almost a 100% turnover from last year. The past year brought a number of staffing challenges and I'll introduce a few who stepped up and joined us this year.

We are pleased to have been able to promote Sierra Franklin to Program Coordinator. Sierra has moved seamlessly into this role and has brought with them enthusiasm for all things youth and breathed new life back into programming (as you can see by our monthly calendar on social media) focused on youth interests that they have gleaned from their years in our organization.

Early in 2023 our Centre Manager moved on to new horizons in Alberta. For about 6 months it was all hands on deck. Thank you to the board for stepping into operations and ensuring continuity of services for our

youth. During this time we were fortunate to have Hilary Nester step in as our interim manager. She was instrumental in securing grant funding for our current fiscal year, maintaining our connections to school and community and filling in wherever she was could help.

I am pleased to introduce Pauline Chevanne, our Centre Manager. She is a long-time valley resident with a strong community network and connections with youth through our school system and previous work experiences. In her short tenure, she has reconnected us to our communities, strengthened our collaboration with schools, created a positive working relationship with CVYN, hired new staff and created a partnership with Hearthstone Counselling to provide 1:1 counselling for youth at a reduced cost.

I would like also like to introduce Emmett Bickley, our Youth Outreach Worker. This position was made possible by the grant from the United Way. In this role Emmett will fill a gap in services for youth. They are able to connect with youth in-person, via the schools, over text or phone call and also to support youth with access to resources within the community and to provide peer support.

On behalf of the Board, our staff and our youth, I would like to thank you our donors for their contributions to our organization. Your donations make this all possible. To our parents, thank you for trusting us with your children. They are the reason why we do this important work. And to our communities and schools for continuing to welcome with open arms.

Centre Directors Report Windermere Valley Youth Centre Society Annual General Meeting November 16th, 2023

The first half of 2023 has been a period of significant change, with almost the entire staff being replaced. Thanks to extraordinary funding, we created a youth outreach worker position. Youth Outreach Workers support atrisk young people by providing referral services, overseeing programs, and addressing their various needs, including social, behavioral, emotional, or educational.

In 2022, the Hub welcomed 3,155 visitors while the Edge only had 143. The numbers for 2023 so far are 2,300 visitors at the Hub and 262 at the Edge. As always, this does not include the numerous interventions in schools and partnerships with other organizations.

For years, Summit Youth Hub has been a cornerstone of the Columbia Valley community, collaborating with non-profits, businesses and schools to develop impactful programs for youth and the wider community. Our goal is to serve as a hub for both young people and community members, fostering important connections and relationships along the way.

The Hub empowers diverse youth communities by offering free programming catering to different interests and needs. We champion equal opportunities and have developed a series of workshops to help youth develop skills that will last for life. The Skills for Life program, created by Sierra, our program coordinator, includes workshops focusing on healthy living, finances, and handiwork.

As always, we participate in as many community events as we can. This year we have attended soccer tournaments, the Valley Appreciation day, the Garlic festival, and we saw the return of our famous Jail N Bail fundraiser during the Harvest festival.

The Windermere Valley Youth Centre Society is a vital part of our community, and we recognize that it thrives because of the support it receives. On August 19th, the first Mountain Mere Music festival was an outstanding success. It brought together people from all backgrounds, who shared a common goal: to improve the mental health of young people. We celebrate successful fundraising and appreciate the generosity of our donors, particularly Sherry Doerr, for their critical contributions.

December 2024 will mark the 30th anniversary of the Windermere Valley Youth Centre Society. We have been supporting youth for almost 30 years already, how amazing. We have big great projects for the future and we cannot wait to share them with you.
